

## VENDOR EXPECTATIONS

By exhibiting in this show, you are agreeing to do the following:

1. Attend and staff your booth for the duration of the show. (See items c.i and e for cancellation info and conditions. No exceptions will be made.)
2. Provide CDWE, LLC. with at least 3 high resolution images to use in promotion of the show and promotion of your business.
3. Conduct at least 2 social media posts about your attendance of this event AND tag the Coulee Dream Wedding Expo.
4. Provide a door prize for guests valued at least \$30 for giveaway during the show.

## VENDOR TERMS AND CONDITIONS

By paying your PayPal invoice, you are agreeing to the following terms and conditions:

- a. Only the business indicated on the registration form is allowed to be displayed in the booth on the day of the event. **Additional businesses in same space must pay same fee.**
- b. All tables and booth spaces must be tastefully presented with appropriate materials related to the products or services sold by the business. You may not display or distribute materials from other business not participating in the event.
- c. You must provide sufficient manpower for your booth during the open times of the event. All vendors must be set up and open for business promptly at show start time. Tear down may not begin until event ends and you will have approx. 2 to 3 hours to do so.
  - i. If you cannot staff your booth, you are responsible for finding a replacement. No refunds will be given for unstaffed booths and unstaffed booths will not receive the contact list at the end of the show.
  - ii. You must speak with us to see what available vendor categories are left.
- d. You are agreeing that the list of registered attendees is for exclusive use of Coulee Dream Wedding Expo 2022 vendors only. The list is not to be sold, lent, bartered or reproduced. It is also agreed that unauthorized use of the list warrants the right of Coulee Dream Wedding Expo to pursue legal action against any and all-in breach of this agreement.
- e. You accept that this contract is non-cancelable.  
All payments rendered will be forfeited for early withdrawal.
- f. Coulee Dream Wedding Expo accepts no responsibility for circumstances out of our control that may force the cancellation or postponement of this event.
- g. Understand that Coulee Dream Wedding Expo and painters will use the exact spelling of Business Name and all links for advertising. Coulee Dream Wedding Expo accepts no responsibility for misspellings and/or exclusions from advertising due to late committal.
- h. You agree that you may not under any circumstance mislead attendees with false promotions.
- i. We do not & cannot guarantee sales. Advertising is done, the rest is up to you. Each vendor is responsible for any sales tax related to their respective business(es).
- j. Spaces are confirmed on a first pay, first completed registration basis.
- k. CDWE does not accept any injury, loss, or damage, that may occur to the business or to the business's employees or property as their own and not the liability of Coulee Dream Wedding Expo or it's partners.
